Members of the Association are required to elect new members to the Board of Directors for a 2-year term (with an option to extend for 1 or 2 years at the Board's discretion) at this meeting. This year there will be three (3) vacancies on the Board. We encourage you to consider running for the Board.

2. Follow the nomination instructions on the form (all candidates must be nominated in writing by two members of the Association).
3. Return the completed nomination form signed by two Association members to the Assistant to the Board, Haidee Nantayi Buzu at School by **3.00p.m. on Monday, April 28, 2025**.

Please note:

1. Parents/guardians of students, are automatically members of the Association and can run for a position on the Board of Directors.
2. Employees of the School and their spouse or immediate family members are not eligible to stand for election.

#### *Voting in Election*

All Association members are eligible to vote. There will be an opportunity to vote electronically in the week leading up to the AGM or in person at the AGM. Results of the election will be announced at the end of the AGM and via email to all Association members the following day.
