### **FUNCTIONS OF THE BOARD**

#### **Powers delegated to the Board of Directors are:**

1. To provide accountability and authority over the school on behalf of The Association.
2. To engage in strategic planning and decision making.
3. To legislate policies in accordance with the school's philosophy and objectives.
4. To ensure responsible fiscal behavior.

### **PRE- REQUISITES**

1. Willingness to serve as a volunteer – the position of Board Member is not paid.
2. One or more years as a member of the school community (preferred).
3. Ability to understand and analyze financial statements including budget and other financial reports.
4. Prior service as board member for a similar-type nonprofit organization (preferred)
5. Understanding and acceptance that it is the Board of Directors' responsibility to "govern" and Head of School's responsibility to "manage."
6. Willingness to accept consensus as a procedure for decision-making.
7. Commitment to the school's mission statement and the culture of the school community.
8. Ability to disassociate from preconceived viewpoints, to be open minded and weigh and consider debate objectively in order to make decisions in the best interests of the school and not from self-interest or to promote the views of a particular constituency.
9. Ability to express oneself succinctly and clearly in verbal and written communication.
10. Ability to analyze and draw conclusions for policy discussion and policy decisions.
11. Commitment to attending Board meeting and committee meetings fully prepared for discussion and/or decisions that will be made.
12. Able to think "globally" and act "corporately" in discussion and decision-making.
